One Hydrological Boundary can have more than one cluster on the basis of irrigation based coverage area of 10 -20 hectares. The potential Hydrological Boundaries shall be grouped into 3 Packages of 125 Units each as under : Package One: - 123 Units/Hydrological Boundaries of Shimla and 2 Units Hydrological Boundaries of Sirmour. Package two: - 66 Units/Hydrological Boundaries of Chamba, 59 Units /Hydrological Boundaries of Sirmour. Package three: - 39 Units/ Hydrological Boundaries of Mandi, 46 Units/ Hydrological Boundaries of Kullu, 6Units/ Hydrological Boundaries of Kangra, 7 Units /Hydrological Boundaries of Solan, 6 Units /Hydrological Boundaries of LahaulSpiti and 21 Units/ Hydrological Boundaries of Kinnaur Note:- <i>Each one of above packages is expected to have an average total area of around 6000 hectares for the purpose of survey, however, the project intervention irrigation target area is expected to be around 7000 hectares. However, there can be increase or decrease in the numbers and location of Units as per actual field situations at a later stage. The bidders may however work out their proposals on the basis of 125 hydrological Boundaries (units) .</i></p> |
